Preston & Steve's Isolation Idol Contest
OFFICIAL CONTEST RULES

These rules apply to Preston & Steve's Isolation Idol Contest ("Contest") conducted by Beasley Media Group, LLC d/b/a WMMR ("Station"). **In addition, the General Contest Rules posted at <https://wmmr.com/official-contest-rules/> apply to this Contest. If there is a conflict between the General Contest Rules and the Rules for this Contest, the Rules for this Contest shall control.**

1. HOW TO ENTER

- a. The Contest will begin on Friday, April 10, 2020 and end on Monday, April 27, 2020.
- b. To enter online, visit <https://wmmr.com/contests/isolation-idol/> and follow the links and instructions to enter the Contest and complete and submit the online entry form beginning on April 10, 2020 at 6:00am Eastern Time ("ET") and ending on April 22, 2020 at 10:30am ET ("Online Entry Period"). Online entrants are subject to all notices posted online including but not limited to the Station's Privacy Policy. Limit one (1) entry per eligible person during the Online Entry Period regardless if entrant has more than one email address. Multiple entrants are not permitted to share the same email address. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Contest administrator.
- c. Each entry must also include an original video of the entrant showcasing the entrant's musical talent or audio performance of said talent (singing, comedy, etc) (each a "Video").
- d. Each Video submitted must feature the entrant and must not contain materials that may be restricted, prohibited, or outlawed by any laws, or materials that may otherwise infringe on the rights of a third party. The Video may not invade publicity rights or privacy of any person, living or deceased, or otherwise infringe upon any person's personal or proprietary rights. The Station shall have the right to disqualify any entrant if it determines that the Video contains copyrighted material or material that infringes on the rights of another; indecent or otherwise offensive material such as violence or drug abuse; or if such Video contains material that is deemed to be unsuitable for a public audience. The Station's determinations with respect to all such matters shall be made in its sole discretion and shall be final. Videos that do not comply with these rules will not be eligible for the Contest. **By submitting a Video, all entrants agree that they have permission to submit the Video and grant Station permission to view their Video for promotional purposes.**
- e. Up to six (6) Videos will be selected at approximately 12:00pm ET each weekday beginning on Friday, April 17, 2020 and ending on Wednesday, April 22, 2020 via judging by Station judges from all eligible Videos received at the time of judging

based on the quality/uniqueness/overall performance in the Video. The entrant who submitted each of the selected Videos will be deemed a “Qualifier” and will be notified by telephone promptly following the selection by the Station judges.

- f. The Qualifiers will be requested to perform either via video call or audio call the weekday following their selection at the time specified by the Station representative between 6:00am ET and 10:30am ET live on The Preston & Steve Show on-air. After each weekday’s performances (starting on Monday, April 20, 2020 and ending on Thursday, April 23, 2020), the Station judges will select up to two (2) Qualifiers to move on to the final round of the Contest based on the judging criteria listed above for a total of up to eight (8) selected Qualifiers. Each selected Qualifier selected to advance to the final round will then be deemed a “Finalist.”
- g. Finalists will be requested to perform once again on Friday, April 24, 2020 at the time specified by the Station representative between 6:00am ET and 9:00am ET live on The Preston & Steve Show on-air.
- h. Up to one (1) Grand Prize winner will be selected via voting from all Finalists previously selected by the Station judges. Finalist info (including but not limited to Name, Photo, Performance description) will be posted on the Contest designated voting page for public voting beginning at 9:00am ET on April 24, 2020 and ending at 6:00am ET on April 27, 2020. Listeners are permitted to submit one (1) vote per day. The Grand Prize winner will be chosen based on the number of votes accumulated and the Finalist with the most votes will be deemed the Grand Prize winner, upon confirmation of eligibility. In the event of a tie, the Station will use the judging criteria above to select the Grand Prize winner from among the Finalists who were tied with the number of highest votes.
- i. If at any time a Qualifier or Finalist is unwilling or unavailable to perform on-air, Station reserves the right to disqualify the Qualifier and/or Finalist.
- j. There will be up to a total of one (1) Grand Prize winner selected in the Contest.

2. ELIGIBILITY RESTRICTIONS

- a. This Contest is open to all Station listeners who are 18 years of age or older as of the date of entry into the Contest, who are legal US residents and reside in Pennsylvania, New Jersey and Delaware, except where prohibited by law. Winners must possess a valid, government-issued ID and show proof of residency to verify eligibility.
- b. **Entrants that are represented by an agent, talent agency, or record label are not eligible to participate unless Station receives written confirmation, in a form acceptable to the Station, that such agency or label representation and any associated commissions or fees are being waived for all purposes of this Contest, Under no circumstances will Station or any party involved with the Contest be responsible for any fee or commission to any agent, label or other representative**

of any Entrant.

3. PRIZES

- a. Up to one (1) Grand Prize will be awarded. The Grand Prize consists of five hundred dollars (\$500) awarded in the form of company check issued in the name of the winner. Approximate Retail Value (“ARV”) of Grand Prize is \$500.

Winner must complete IRS Forms in order to process the prize check. No check will be awarded, processed or mailed until winner has claimed the prize via competing appropriate forms, presented all required documentation, and signed all required releases and tax forms. Checks will then be mailed to the winner within approximately sixty (60) days following confirmation of eligibility and completion of all requisite releases and IRS forms.

- b. Prizes or prize certificates must be claimed as notified at the time of winning. Prize or prize certificate must be claimed within thirty (30) days of winning. Failure to claim Prize by the specified time will result in forfeiture of the prize. It is the winner’s sole responsibility to claim the Prize or prize certificate within the timeline provided in these Official Rules.

4. SELECTION OF WINNERS

- a. Up to one (1) Grand Prize winner will be selected as described above. Potential Grand Prize winner will be notified by phone and/or email promptly following the end of voting. The winner will also be announced on-air between 6:00am ET and 10:00am ET on Monday, April 27, 2020.
- b. Entrants do not need to listen to the Station or be present to win the Grand Prize.
- c. Grand Prize winner must confirm acceptance of prize within one (1) day of being announced the winner, or risk disqualification and selection of an alternate Grand Prize winner (time permitting) from the Finalist with the next highest number of votes.
- d. Decisions of Station management with respect to the Contest are final.

5. CONDITIONS

- a. The Station reserves the right to end any contest or amend these rules upon announcement on air and by publication at www.wmmr.com.
- b. For website contests: By use of the Station’s website and by entering this Contest, entrants agree to the Station’s Terms of Service Agreement and to the use of Personal Information as stated in the Privacy Policy located at www.wmmr.com.
